2. ABML, Inc. (the "Other Business Entity") is a corporation that was incorporated under the laws of Florida on September 23, 2003.

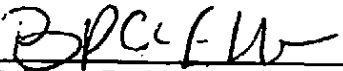

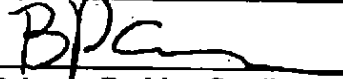
