The Company's existence shall commence effective as of March 15, 2021 and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.

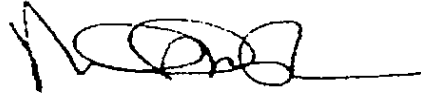
**ARTICLE IV

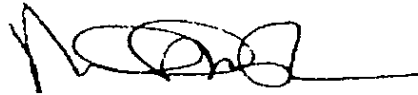
