## ARTICLES OF ORGANIZATION OF PORTOFINO EAT, LLC

The undersigned, RHETT J. WILLIAMS, a natural person competent to contract and an authorized representative of PORTOFINO EAT, LLC, hereby presents these Articles of Organization as the Articles of Organization of PORTOFINO EAT, LLC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.
