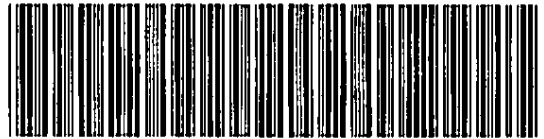

All the remaining property and assets of the Company have been distributed to all Members of the Company.


**ARTICLE VII
