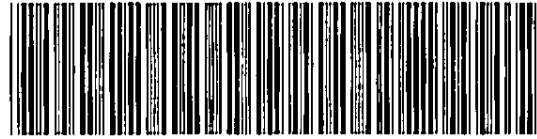

The name of the registered agent is **Deliana Rojas-Munoz** and whose Florida street address is **310 Kays Landing Drive, Sanford, FL 32771**.


