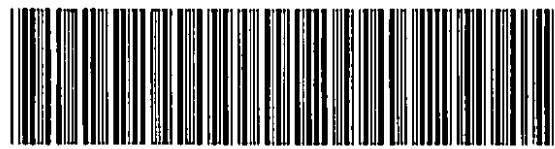

ARTICLES OF ORGANIZATION
OF
AKP THRIFT, LLC

The undersigned hereby organizes a limited liability company under the provisions of the Florida Revised Limited Liability Company Act, and pursuant to the following Articles of Organization:

ARTICLE 1
Name

The name of this limited liability company is:

(hereafter, the "Company").

ARTICLE 2
Mailing Address and Principal Office

ARTICLE 6
Purposes of the Company

The purpose of the Company is to aid and benefit foster, neglected and abused children, directly or indirectly, by creating, operating and/or supporting programs for neglected and abused children (including operating a residential program for children who have been removed from their homes due to crises), by raising and administering funds for their financial support, providing volunteer services, or otherwise taking action for the benefit of foster, neglected and abused children.

ARTICLE 7
Indemnification

The Company shall indemnify its member to the fullest extent authorized by law.
