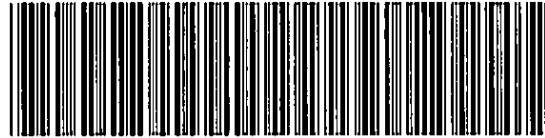

II. PRINCIPAL OFFICE




