1. The Articles of Organization of ALTERNATIVE SUSTAINABILITY LLC a Florida limited liability company (the "Company"), were filed on March 24, 2021 and assigned document number L21000122128.
2. These Amended and Restated Articles of Organization were approved by the Members of the Company, to be effective September 26, 2022.
3. These Amended and Restated Articles of Organization are submitted to amend and restate the Articles of Organization of the Company in its entirety to read as follows:

**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION

Pursuant to § 605.0201 of the Florida Revised Limited Liability Company Act, Florida Statutes, as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

**ARTICLE I
NAME**

The name of the limited liability company is Alternative Sustainability LLC (the "Company").

**ARTICLE II
EFFECTIVE DATE AND DURATION**

The effective date upon which the Company came into existence is May 24, 2021. Unless earlier terminated pursuant to the Act or the Operating Agreement (as defined in § 605.0105 of the Act) of the Company, the period of its duration shall be perpetual.

The registered office of the Company shall be 2273 Stockton Drive, Fleming Island, FL 32003 and its registered agent at such office shall be John Goetz.


