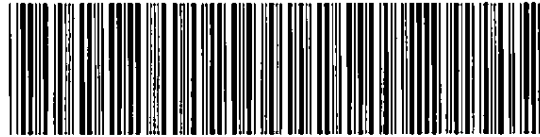

NAME


