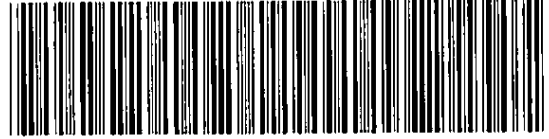



## **ARTICLES OF ORGANIZATION**

## ARTICLE X - AMENDMENT

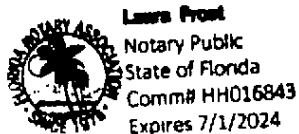
