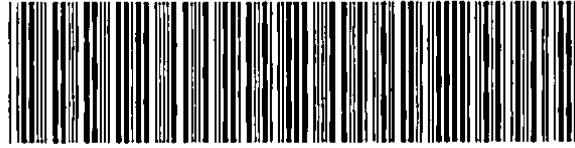

A Florida Limited Liability Company

I, the undersigned, am a natural person eighteen years of age or older. I am acting in the capacity of Organizer of a limited liability company pursuant to the Florida Limited Liability Company Act (the "Act"). I hereby adopt the following Articles of Incorporation for such limited liability company.

Article I

- (f) To have and exercise all rights and powers that are now or may hereafter be granted to a limited liability company by law.

3.03 The Company may, in its Regulations, confer powers, not in conflict with law, on its Manager(s) and Members in addition to the foregoing and in addition to the powers and authorities expressly conferred on them by statute.

##### Indemnification

7.03 This indemnification shall not be exclusive of other's rights to which the Managers may be entitled.


7.04 The Managers shall be entitled to the fullest indemnification allowed by the current law may be amended hereafter.

- (d) An action for which the Manager is liable at law and for which an indemnification is not allowed.
