**ARTICLES OF ORGANIZATION
OF
VENICE PIZZA, LLC**

ARTICLE I – Name:

The full and complete name of this Florida limited liability company is “Venice Pizza, LLC” (the “*Company*”).

ARTICLE II – Mailing Address and Principal Office:

ARTICLE VIII – Continuation of Business:




