ARTICLES OF ORGANIZATION****OF****BAY SECURITIES MANAGEMENT, LLC**

I. 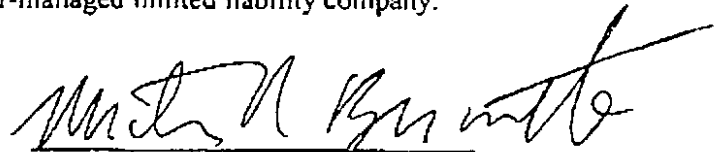
