**ARTICLE I – NAME**

**ARTICLE VIII – OFFICERS**

The Company shall indemnify, advance expenses, and hold harmless, to the fullest extent permitted by applicable law as it presently exists or may hereafter be amended, any Manager or officer of the Company who was, is made or is threatened to be made a party or is otherwise involved in any action, suit or proceeding, whether civil, criminal, administrative or investigative ("Proceeding"), by reason of the fact that he or she, or a person for whom he or she is the legal representative, is or was a Manager or officer of the Company or, while a Manager or officer of the Company, is or was serving at the request of the Company as a Manager, officer, employee or agent of another Company or of a partnership, limited liability company, joint venture, trust, enterprise or nonprofit entity, including service with respect to employee benefit plans, against all liability and loss suffered and expenses (including attorneys' fees) reasonably incurred by such Manager or officer. Notwithstanding the preceding sentence, except for claims for indemnification (following the final disposition of such Proceeding) or advancement of expenses not paid in full, the Company shall be required to indemnify a Manager or officer in connection with a Proceeding (or part of a Proceeding) commenced by such Manager or officer only if the commencement of such Proceeding (or part of a Proceeding) by such Manager or officer was authorized in the specific case by the Manager. Any amendment, repeal or modification of this Article IX shall not adversely affect any right or protection in these Articles of Organization of any person in respect of any act or omission occurring prior to the time of such repeal or modification.
