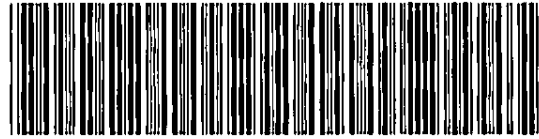

This limited liability company shall be managed by one or more Managers in accordance with the Operating Agreement of this limited liability company.

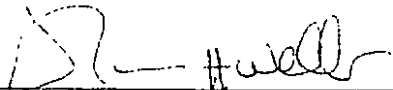

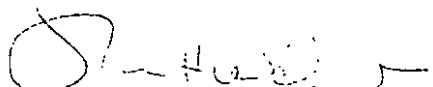
