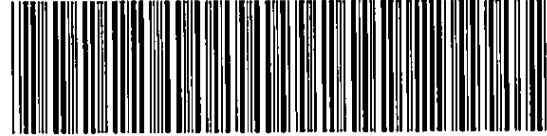

**Management**






