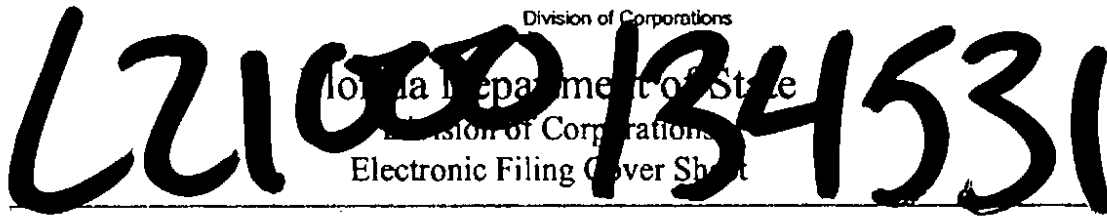

ARTICLES OF ORGANIZATION

ARTICLE 1
