**ARTICLE VI - MANAGEMENT**

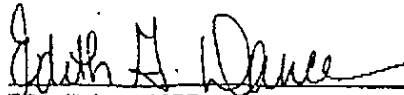

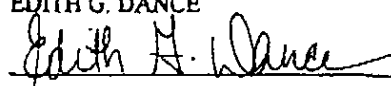
