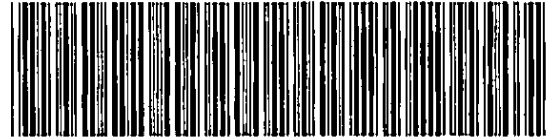

ARTICLES OF CONVERSION

Pursuant to the provisions of Section 605.1045 of the Florida Revised Limited Liability Company Act (the "Act"), CHAOS CAPITAL INVESTMENTS, INC., a Georgia corporation (the "Converting Entity"), hereby delivers these ARTICLES OF CONVERSION for the purpose of converting the Converting Entity from a Georgia corporation to a Florida limited liability company pursuant to the provisions of O.C.G.A. Section 14-2-1109.3 of the Georgia Code and Section 605.1041(3) of the Florida Revised Limited Liability Company Act.

1. The Converting Entity was incorporated on May 9, 2003, pursuant to the laws of the State of Georgia, as a Georgia for profit corporation.
2. The name of the Converting Entity immediately prior to the filing of these Articles of Conversion was CHAOS CAPITAL INVESTMENTS, INC.
3. The name of the converted entity immediately after the filing of these Articles of Conversion will be CHAOS CAPITAL INVESTMENTS, LLC, which will be a Florida limited liability company upon filing its Articles of Organization with the Florida Department of State.
4. The conversion will be effective on the date of filing these Articles of Conversion and Articles of Organization with the Florida Department of State.
5. The plan of conversion has been approved by the Converting Entity in accordance with O.C.G.A. Section 14-2-1109.3.

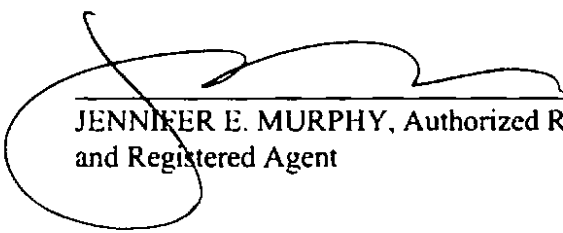
