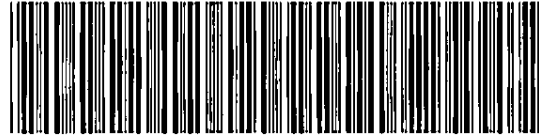

ARTICLE I: NAME

The name of the Company shall be 2880 1st Ave N Partners LLC.

ARTICLE II: ADDRESS AND PLACE OF BUSINESS

The initial address of the principal office and the mailing address of the Company shall be 150 2nd Ave N, Suite 710, St. Petersburg, FL 33701.

ARTICLE III: DURATION AND PURPOSE

ARTICLE V: REGISTERED OFFICE AND REGISTERED AGENT




