ARTICLES OF ORGANIZATION OF TERRICK, LLC

1. **NAME.**

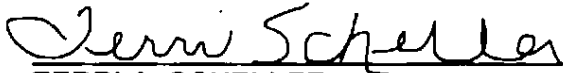
