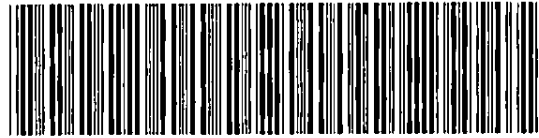

- THIRD: The following amendment to the Articles of Organization was adopted by the limited liability company:


Article IV of the Articles of Organization of the Company is hereby deleted in its entirety and replaced with the following:
