**ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION OF

1. The Company's Articles of Organization are hereby amended by deleting the present form of Article V in its entirety and by substituting, in lieu thereof, the following:

**"ARTICLE V
MANAGEMENT OF THE COMPANY"**

The Company shall be managed by a manager or managers who shall be elected by the members in the manner set forth in the Company's Operating Agreement. The Managers shall be Alan Smith, Loren Grandstrom, David Palmer, Mike Geyer, Andrew Kinney, and William B. Evans."
