"ARTICLE V

The Company shall be managed by a manager or managers who shall be elected by the members in the manner set forth in the Company's Operating Agreement. The Managers shall be Alan Smith, Loren Grandstrom, David Palmer, Mike Geyer, and William B. Evans."
