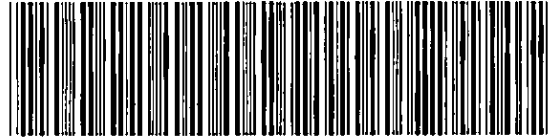

2. The name of the Converted Entity as set forth in the attached Articles of Organization is BHL Holdings, LLC, a Florida limited liability company.

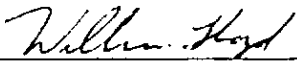
