### ARTICLES OF ORGANIZATION

In addition to the indemnification conferred in this Article, the Indemnifice shall also be entitled to have paid directly by the Company the expenses reasonably incurred-in defending any such proceeding against such Indemnitee in advance of its final disposition, to the fullest extent authorized by applicable law, as the same exists or may hereafter be amended. The rights and authority conferred in this Article shall not be exclusive of any other right which any person may have or hereafter acquire under any statute, provision of the Articles of Organization or Operating Agreement of the Company, agreement, vote of Members or otherwise. Any repeat or amendment of this Article by the Members of the Company shall not adversely affect any rightion protection of a manager or officer existing at the time of such repeal or amendment.

The Company is authorized to issue both voting and nonvoting member certificates. All common member certificates shall be identical in all respects except the nonvoting member
