**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
FAST LANE SOLUTIONS LLC**

WHEREAS, the name of the company is Fast Lane Solutions LLC, a Florida limited liability company ("Company"); and

WHEREAS, the Company was formed pursuant to the laws of the State of Florida with an effective date of April 11, 2021 and assigned document number L21000169914; and

WHEREAS, the sole Member of the Company has recommended the amendment to the Articles of Organization set forth below; and

WHEREAS, the undersigned Company, by and through its Member and Manager and pursuant to the provisions of Section 605.0202 of the Florida Statutes, hereby amends the aforesaid Articles of Organization in the manner hereinafter set forth;

NOW, THEREFORE, the undersigned hereby amends the Articles as follows:

1. The Articles are hereby amended by adding Article V as follows:

**"Article V
Management"**

The Company shall be managed by the Manager of the Company as provided in the Company's Operating Agreement. The initial Manager of the Company is Colby Free, whose address is 7049 Sawmill Cir., Ocoee, Florida 34761, who shall serve until replaced according to the provisions of the Company's Operating Agreement."

2. The date of the foregoing amendment's adoption was November 23, 2021.
3. Except as modified herein, the Articles of Organization of said Company shall be and remain in full force and effect.
