ARTICLE V

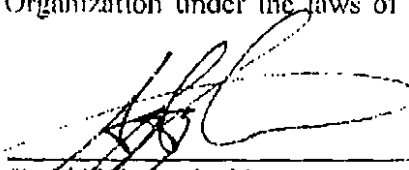

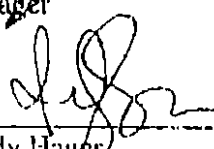
