ARTICLES OF ORGANIZATION OF U.S. GOLD GYMNASTICS, LLC

The undersigned, Kathleen Dwyer, a natural person competent to contract and an authorized representative of U.S. Gold Gymnastics, LLC, hereby presents these Articles of Organization as the Articles of Organization of U.S. Gold Gymnastics, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is U.S. Gold Gymnastics, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II – PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSE AND POWERS
