
# ARTICLE VII NEW MEMBERS



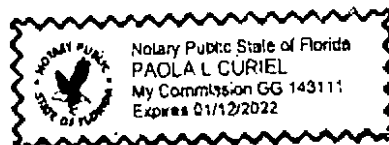
