**ARTICLES OF ORGANIZATION
of
TATK PROPERTIES, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be TATK Properties, LLC (the "Company"). The mailing and street address of the principal office of the Company shall be 156 West 7th Street, Jacksonville, Florida 32206.

ARTICLE II

PURPOSES AND POWERS

The managers shall be elected in the manner set forth in the Operating Agreement of the Company. 


