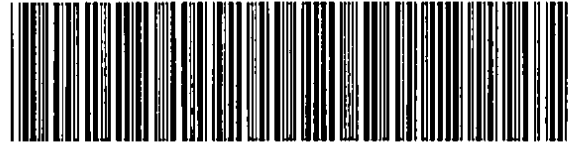

STATEMENT OF AUTHORITY
(LIMITATION)**

Pursuant to Florida Statutes Sections 605.0302(1) & (7) and 605.04074(3), as subsequently amended and/or replaced, the Florida limited liability company named below hereby submits the following Statement of Authority:

FIRST: The name of the limited liability company is: GCOS, LLC (hereinafter referred to as the "Company").

SECOND: The Florida Document Number of the Company is:
L21000180642.

THIRD: The street address of the Company's principal office is: 1535 Northgate Blvd., Unit 1, Sarasota, FL 34234. The mailing address of the Company's principal office is: 1979 Palm View Rd., Sarasota, FL 34240.

FOURTH: This Statement of Authority limits the authority of all persons having a status or position with the Company, whether as a member, manager, transferee, officer, agent, employee, or otherwise (hereinafter referred to collectively as a "Company representative") as follows:

1. Without having first obtained the prior written consent of all the Company's Members, no Company representative shall cause or permit the Company to sell, convey, transfer, assign, mortgage, refinance, pledge, encumber, trade, exchange, or otherwise dispose of, or lease for more than two (2) years, or execute and deliver any deed, mortgage, or lease of, any Company real property or any part or interest therein.

2. In addition, the Company's Articles of Organization include other limitations and restrictions on the Managers of the Company which shall continue in effect until amended or terminated in accordance with Florida Statutes Chapter 605.
