**ARTICLES OF ORGANIZATION

MANAGEMENT



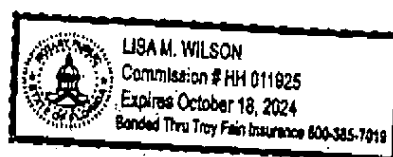


