ARTICLES OF ORGANIZATION OF JERSEY JUICE DAIRY, LLC

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 605 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

ARTICLE I

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is Jersey Juice Dairy, LLC.

ARTICLE II

ARTICLE III MANAGEMENT

The business of the Company shall be managed by a Manager elected by the Member(s). The initial Manager shall be Timothy Ray Morrison, who shall serve as a Manager of the Company until his resignation or death, or as otherwise provided in the Operating Agreement of the Company.

Any amendment to these Articles of Organization shall be on such form prescribed by the Florida Secretary of State, containing such terms and provisions consistent with Chapter 605 of the Florida Statutes, and approved by the Manager of the Company.

ARTICLE VI REGISTERED AGENT AND REGISTERED OFFICE
