**ARTICLES OF ORGANIZATION
OF
JERSEY JUICE DAIRY, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to Chapter 805 of the Florida Statutes, entitled the Florida Revised Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

**ARTICLE I
NAME**

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is Jersey Juice Dairy, LLC.

**ARTICLE II
ADDRESS**

Any amendment to these Articles of Organization shall be on such form prescribed by the Florida Secretary of State, containing such terms and provisions consistent with Chapter 805 of the Florida Statutes, and approved by the Manager of the Company.






