**ARTICLES OF ORGANIZATION
OF
PUERTO 105 LLC**

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is Puerto 105 LLC (the "Company").

ARTICLE II

ADDRESS

ARTICLE III

REGISTERED AGENT AND REGISTERED OFFICE

ARTICLE IV

MANAGEMENT

DANIEL RIOS, P.A., shall have no power or authority to bind the Company with respect to any other matters relating to the Company's purpose, except as stated herein.
