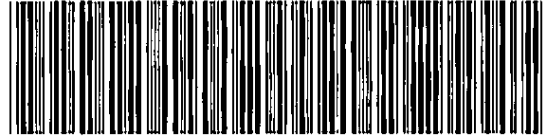

**ARTICLES OF ORGANIZATION
OF
2750 LEEWARD, LLC,
a Florida Limited Liability Company**

The undersigned, being the duly authorized representative of the initial members of a limited liability company to be organized under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, adopts and submits the following Articles of Organization for such limited liability company:

**ARTICLE I
NAME**

The name of the limited liability company is **2750 Leeward, LLC**, a Florida limited liability company (the Company).

**ARTICLE II
PRINCIPAL PLACE OF BUSINESS**

The mailing address and street address of the principal office of the Company shall be **1590 Nautilus Rd., Naples, Florida 34102**.

**ARTICLE III

Newly admitted members shall have all of the rights and privileges as set forth in the Companys Operating Agreement and Regulations.

EFFECTIVE DATE**

The Companys effective date of existence shall begin on the date of filing of these Articles.

**ARTICLE VI
DURATION**

The Companys duration shall be perpetual. Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or any other event that would terminate the continued membership of a member in the Company, the remaining members shall have the right to continue the business of the Company as provided in the Operating Agreement and Regulations.

ARTICLE VII ADOPTION OF OPERATING AGREEMENT AND REGULATIONS


