**ARTICLES OF ORGANIZATION

Restrictions on Transfer and Operating Agreement

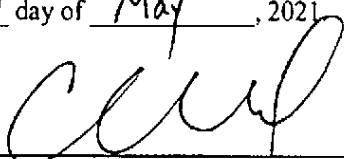
