The name of the limited liability company shall be "SJWM, LLC" (hereinafter referred to as the "Company").


ARTICLE II - PRINCIPAL OFFICE & MAILING ADDRESS

The street address and mailing address of the principal office of the Company is 130 Richard Jackson Blvd., Suite 200, Panama City Beach, Florida 32407.


ARTICLE III - REGISTERED AGENT
