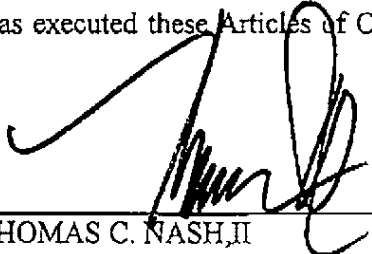
ARTICLE VIII
