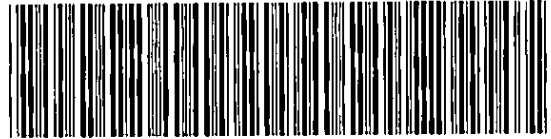

Management




