**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF

Pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, the undersigned manager and authorized representative of the Member, hereby adopts the following amended and restated articles of organization (the "Amended and Restated Articles of Organization") of SURF SAND AND SEA, LLC, a limited liability company duly organized and existing under the laws of the State of Florida, as filed on May 12, 2021 and assigned document number 1.21000209596, and confirms that these Amended and Restated Articles of Organization hereby amend and restate the provisions of the Company's original Articles of Organization in their entirety:
