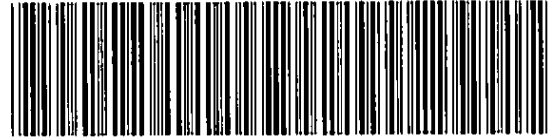

ARTICLES OF ORGANIZATION

NAME


