



### AMENDMENT TO ARTICLES OF ORGANIZATION/ OPERATING AGREEMENT

This Amendment Number One ("Amendment") is made to the Operating Agreement of Parismee LLC (the "Company") by and among Nestor Sucko, Daniel E. Parisone, Cristian A. Parisone and Domenico Parisone (collectively the "Members") effective this 1st day of November, 2021

#### RECITALS:

The Members desire to amend the Operating Agreement of the Company dated May 11, 2021 (the "Operating Agreement") to recognize and give effect to the termination of Nestor Sucko, Cristian A. Parisone and Domenico Parisone Membership Interests

NOW THEREFORE, in consideration of the mutual covenants and undertakings herein, the parties agree as follows

- Examination of Nestor Sucko, Cristian A Parisone and Domenico Parisone.

  Membership Interests: Nestor Sucko, Cristian A Parisone and Domenico Parisone are removed as members of the Company. All references to Nestor Sucko, Cristian A Parisone and Domenico Parisone in the Operating Agreement are deleted. In the event the deletion of references to "Nestor Sucko", "Cristian A. Parisone" and Domenico Parisone" causes any provision of the Operating Agreement to have no effect, then such provision is deleted. In the event the deletion of references to "Nestor Sucko", "Cristian A. Parisone" and Domenico Parisone" result in only a partial deletion of a provision in the Operating Agreement, and such provisions continue to have effect, the parties agree to interpret such provision in a manner which gives effect to such provision without their ("terminated members") interest.
- 2 <u>Manager of the Company</u> The sole Member of the Company "Daniel E Parisone" be, and is hereby authorized and directed by a majority vote of the Members to operate and act as the manager of the Company pursuant to ARTICLE 4 of the Agreement
- 3 Entire Agreement Except as provided herein, the Operating Agreement shall continue in full force and effect. Capitalized terms used herein, but not otherwise defined, shall have the meanings set forth in the Operating Agreement.

The Secretary shall amend the document, file the document with the proper state agencies, if necessary, and distribute the amended document to the members of the company
