Additional Article VI Provisions

ARTICLE VI: Purpose of Business:

The Company shall be a "qualified opportunity zone business" as such term is defined in Section 1400Z-2(d)(3) of the Code, with the objective of qualifying any interests in the Company as "qualified opportunity zone partnership interests" as such term is defined in Section 1400Z-2(d)(2)(C) of the Code; provided, however, ensuring any such interest is issued solely in exchange for cash, as required by Section 1400Z-2(d)(2)(C)(i), or ensuring any such interest is acquired and owned by a Qualified Opportunity Fund (as such term is defined by Section 1400Z-2(d)(1) of the Code) shall be the responsibility of each individual Member and not the Company. The Manager shall have the authority to take any action the Manager deems necessary in his or her sole discretion to conform the Company's holdings and activities to comply with Section 1400Z-2 of the Code and any final, temporary, or proposed Treasury Regulations thereto. The Company shall be prohibited from conducting any business or other activity that may result in a violation of Section 1400Z-2(d)(3)(A)(iii) of the Code.
