

ARTICLES OF ORGANIZATION of GIBSONTON RE-2, LLC

- 1. NAME. The name of this limited liability company is Gibsonton RE-2, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.
- 2. PLACE OF BUSINESS. The mailing address and street address of the Company's principal office is 6300 N. Sagewood Drive, Suite H-117, Park City, UT 84098.
