ARTICLES OF ORGANIZATION
of

1. **NAME.** The name of this limited liability company is Gibsonton RE-1, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. **PLACE OF BUSINESS.** The mailing address and street address of the Company's principal office is 6300 N. Sagewood Drive, Suite H-117, Park City, UT 84098.


