
To whom it may concern,

I am writing in response to Letter Number: 210504131409-900364872899, received on 5/4, advising me that the registration for my **LLC*** was not processed because **“The name designated in your document is unavailable because it is the same as or not distinguishable from an existing entity. If the principals are the same in both entities, please send a letter or affidavit advising us of this association, along with your document so that we may complete the filing process.”**

Indeed, I mistakenly filled for a new **CORPORATION**** instead of an LLC on 4/21 and had to wait until that application had gone through to file for its dissolution. As such, I am listed as the principal for both entities. I received the Articles of Incorporation on 5/3 and filled for dissolution on 5/6 (receipt is attached). **The only entity I meant to create and wish to keep is the LLC.**

I hope I have provided enough context to allow the LLC filing process to resume.
