
Dear Jessica,

I am writing in regard to my LLC filing for Robert Shoemaker, LLC. The document number is L18000171940. In the spring of last year, 2020, due to COVID I missed filing my annual report by the April 30<sup>th</sup> deadline and subsequently the LLC was re-classified as Inactive. In August of last year, I re-filed a charter for a new LLC with the same name- Robert Shoemaker. Last week while I was attempting to file the annual report someone in your department alerted me that the new filing was not accepted and that I needed to write to you letting you know that I have no intentions of using the original LLC but instead have filed a new charter. So, on 5-5-21 I filed a new LLC charter on-line and I used the tracking number 700354132627 in order to use the filing fee credit from the filing last year that was not accepted.
