

Amended and Restated Articles of Organization of the WeR5 LLC

A Florida Limited Liability Company

Section 1.01 Introduction and Preliminary Statements

Section 1.11 Business Continuation

If a Company Member's membership in the Company is terminated by an event, the remaining Members and Managers of the Company have the right to continue the Company's business under the terms of the Operating Agreement. A terminating event may include the Member's death, disability, retirement, resignation, withdrawal, expulsion, or bankruptcy.
